

## **THE RETHINK GROUP TERMS OF USE**

These Terms and Conditions of Use (the “Terms of Use”) apply to the websites, mobile applications, and software owned or operated by The reThink Group, Inc. If we are unable to resolve any such dispute within a reasonable time (not to exceed thirty (30) days), then either party may submit such controversy or dispute to mediation. If the dispute cannot be resolved through mediation, then the parties shall be free to pursue any right or remedy available to them under applicable law.
